

WHAT ARE THE REFORMS?







Benefits for children and families

The Reforms promote the wellbeing and safety of children by:

- Improving earlier identification and enabling earlier support and engagement with relevant services
- Supporting a collaborative, coordinated and integrated approach to service delivery across the service sector
- Empowering professionals to make informed decisions about the needs of the children and families in their care
- Promoting a shared responsibility for wellbeing, safety and identifying and responding to family violence across the service sector







WHO CAN SHARE INFORMATION?



27 September 2018 Phase One

Examples include:

- Child Protection
- Integrated family services (including Child First)
- Out-of-Home Care
- Maternal and Child Health services
- The Orange Door (formerly Support and Safety Hubs)
- Specialist family violence services and RAMPs
- Sexual assault services
- Designated Mental health services
- Alcohol and other drugs services
- DHHS Housing and selected homelessness services
- Victoria Police
- Youth Justice & Youth Parole Board
- Justice Health (children and young people only for CIS)
- Victim's Support Agency and Victim Assistance Programs
- Multi Agency Panels for Youth Offending (MAPs)
- Registry of Births, Deaths and Marriages



Education Portfolio Workforces

Examples include:

- Government schools
- Catholic schools
- Independent schools
- DET funded/delivered student disengagement and wellbeing programs and services




CHILD WELLBEING AND SAFETY OBLIGATIONS















CISS and FVISS provide additional permissions to share relevant information







SAFEGUARDS FOR THE REFORMS



Only prescribed organisations and services can share



Organisations are bound by Ministerial Guidelines



Professionals (ISEs) are trained and have access to supporting resources



Good faith defence provides protection for professionals



Complaints can be lodged





CISS IN ACTION

9 year old Dillon attends the local general practice with pains in his stomach.

The general practice nurse (GPN), Tayla, notes that Dillon has attended the clinic several times in the last 6 months with similar symptoms and informs her colleagues.

The GPN undertakes agreed biomedical and general assessment. During the assessment Dillon says that he hates school and that he is being picked on by some other kids. Mum (Faye) is aware of the bullying, but didn't realise that it could be causing Dillon's physical symptoms.

The GPN discusses information sharing arrangements with mum and mum can see how sharing the information will help improve Dillon's wellbeing and safety.

- ✓ The GPN is permitted to share
- ✓ Sharing to promote wellbeing and safety
- ✓ Sharing to inform an action
- ✓ The views and wishes of the supportive family members have been sought







CISS IN ACTION

Mum appreciates Tayla's clear explanation and agrees to the suggestion.

The GPN contacts the nurse at Dillon's school and shares relevant information about his experience of being bullied. She also shares information about the health-care team's planned follow-up appointment to check on Dillon's mental and physical health. Both the general practice and school document the information shared.

Dillon and mum are connected into Kids Helpline resources.

The school nurse liaises with the designated school team, including the wellbeing coordinator.

Strategies and support are put in place at school, including a problem -solving skills support program to address and minimise the impact of the bullying.

The ISEs continue to collaborate and share information to support Dillon and ensure wraparound services optimise his wellbeing.


- ✓ Both services are ISEs
- ✓ The requirements for sharing are met
- ✓ Sharing to inform an action
- ✓ Information is not excluded
- ✓ Record-keeping requirements are completed







RECORD KEEPING REQUIREMENTS UNDER CISS









WAYS YOU CAN SHARE INFORMATION UNDER CISS

How do I share the information?

- Follow your organisations information sharing process
- Follow the process of the organisation you are sharing with
- Seek guidance from your relevant Department
- Processes may include email, phone call, forms or templates

Ensure the person you are sharing with is who they say they are and are from a prescribed ISE









SHARING INFORMATION UNDER CISS & FVISS

Can I share information to promote the wellbeing or safety of a child or a group of children under the Child Information Sharing Scheme?



Is my organisation a prescribed Information Sharing Entity (ISE)?



Am I authorised by my organisation to share information under CISS and FVISS?



Is the organisation I am sharing with a prescribed ISE?



Does the information meet the requirements for sharing under CISS or FVISS?



Have I sought the views and wishes of the child or relevant family members?



Ensure legislated record-keeping requirements and those of my organisation are met.
